Constructed approximately 25 years ago, the property is of timber frame construction and benefits from a strong C1 BER rating, ensuring comfort and energy efficiency.

The ground floor accommodation is both spacious and well-proportioned, comprising a large, light-filled living room with a fitted stove, creating a warm and inviting family space. A separate dining room to the front features patio doors opening out to the garden, ideal for entertaining. To the rear, the kitchen is fitted with solid units and complemented by a large central island/breakfast bar. A utility room with rear access adds further practicality. Also on the ground floor are three generously sized double bedrooms, all of which are ensuite, along with a guest WC.

The first floor, converted from the attic, offers excellent additional accommodation with a number of versatile rooms, a family bathroom, and extensive storage within the eaves—ideal for a growing family, home office, or hobby space.

Externally, the property is equally impressive. The home is approached via a gated entrance with stone boundary walls and a sweeping tarmac driveway surrounding the house.

The landscaped gardens are mature and private, complemented by a large patio area perfect for outdoor dining and relaxation.

Additional features include oil-fired central heating, double glazed windows and doors a private well and a septic tank system. This is a superb family home finished to a high standard both internally and externally, offering space, privacy and a prime countryside setting.
